Award Description	<p>Under CFDA 10.568 (for ARRA-TEFAP Admin Funds), the CNMI-PSS received a combined award of \$7,713. The \$7,713 award is comprised of \$4,096 for FY2009; \$3,573 for FY2010; and \$44 in recovered and reallocated ARRA Admin funds. (ARRA reporting is required only for CFDA 10.568.)</p> <p>Under a CFDA 10.569 award, an additional amount of \$16,343 was received for ARRA TEFAP - Food Entitlement Funds. Unlike other states, the CNMI TEFAP Food Entitlement Funds award is entirely cashed out on a regular basis. This is due to the fact that the food entitlement award is very small and therefore more practical to purchase food locally for the program.</p>
